Membership Report

Reminders to pay WLPOA dues for 2011 were sent out in February. If you need a membership form please contact me by phone or email.

To date we have received renewals from 75 members and 22 people are signed up to receive our Newsletter as "Friends of Windigo". Your support is critical to our association and it is very much appreciated

Our membership form also provided options for making voluntary donations to our Invasive Species Fund and our new Fish Crib Fund. Donations to the Invasive Species Fund were received from 26 members and 15 members contributed to the Fish Crib Fund. Dollar totals for these contributions are shown in the accompanying Treasurer's Report. WLPOA serves property owners on Windigo Lake, Hub Lake, and Lake 27 by protecting our lakes from invasive species, working with the DNR and local government to maintain lake quality and promoting communication and cooperation among lakeshore owners. WLPOA, Inc. is a nonprofit 501(c) (3) organization so your membership donation is taxdeductible as provided by law.

Treasurer's Report

To date our 2011 income is as follows:

- We have received \$ 1,985 in dues from 75 members and 22 "Friends of Windigo" subscriptions.
- Donations to the Invasive Species Fund totaled \$ 745 and donations to the new Fish Crib Fund totaled \$ 235.
- Forty-seven tickets at \$ 14 each were sold to the May 7th Spring Dinner for a total of \$ 658. Meal expenses were \$ 690.

Our annual operating budget is about \$ 1,600. This covers our membership mailing, the printing and mailing of three Newsletters, signs for our boat landing, purchase and maintenance of "no wake" buoys, our liability insurance, and memberships in the Wisconsin Association of Lakes and the Sawyer County Lakes Forum. The WLPOA account balances are:

- Checking Account: \$ 1,869. This account is used for our operating budget.
- Invasive Species Account: \$ 5,929. This fund was set up to deal with the invasive species threat; our plan is to build this fund up to \$ 10,000.
- Fish Crib Fund Account: \$ 235. These funds will be used to repair or replace fish cribs that WLPOA placed in Windigo some years ago.

Spring Survey Undertaken for Invasive Species

In light of the rapid spread of a variety of invasive species throughout the lakes of Sawyer County the WLPOA has requested that local biologist, Mike Heim, return to the lake for a survey of the lake for invasive species this spring in addition to the fall survey he has taken in the past. Since invasive plants bloom at different times of the year it was thought wise to undertake an inspection early and late during the aquatic plant growing season. Spring would also be an ideal time for the lake's Bay Captains to review their respective geographic areas for problematic growth and to take questionable plants to the Sawyer County Conservation Department in the Sawyer County Court House for identification. Recent studies have determined that there is a material decrease in property values on lakes afflicted by one or more invasive species and thus it would behoove all property owners to keep a sharp look out for plants depicted on the invasive species cards recently mailed to the membership.

UPDATE:

The scheduled spring survey of the lake for invasive species took place last Saturday with biologist Mike Heim accompanied by Colleen Graham and Paul Neimann. Fortunately nothing disturbing was discovered (unless you considered the weather). Of course all lake owners should remain diligent for AIS for the rest of the year.


<u>Changes in Sawyer County Shoreline-Wetland Protection Ordinance in</u> <u>the Offing</u>

The Wisconsin State Legislature passed in 2010 an updated rule known as NR115 so as to better protect shore lands and which requires all counties to update their existing ordinances to comply with the new rule. Sawyer County is presently in the process of amending its existing ordinance which process must be completed by February, 2012. While it is not possible to summarize all the proposed changes here, a copy of the changes may be obtained at the Office of Zoning at the Sawyer County Court House. Since the property owners of the lake have done an outstanding job of maintaining the shoreline in its natural and wild condition and the lake is not overly developed, the impact of the ultimate revisions to the existing ordinance may be minimal. Perhaps the best advice for the time being is simply to keep your property and shoreline as it is.

Invasive Species Monitoring & Action Plan for Windigo Lake

Although Windigo will be professionally surveyed in the spring and fall for invasive species (IS), we also rely on property owners to identify and report suspicious plants. Towards that end, the WLPOA board consulted with Kristi Maki, the Sawyer County Aquatic Invasive Species Coordinator, to create a plan to monitor Windigo. Earlier this year, photographs of IS (along with similar native counterparts) were sent to property owners. Please take the time to familiarize yourself with IS and follow the reporting instructions in the action plan below in the event you find an IS on Windigo. Also, if you'd like to volunteer to be on the plant removal team, please contact a board member. Thank you!
